### KIRTLAND CITY COUNCIL MINUTES

### **April 16, 2012**

The meeting of Kirtland City Council was called to order at 7:08 p.m. by Council President Pro Tempore Timothy Powell. Mr. Webbe led the prayer which followed the Pledge of Allegiance. The members of Council present were: William Catania, David Kirek, Timothy Powell, Robert Skrbis, R. Robert Umholtz and Donald Webbe. Absent: Matthew Schulz.

Administrative personnel present were: Mayor Mark A. Tyler, Law Director Daniel Richards, Finance Director Keith Martinet, City Engineer Philip Kiefer, Service Administrator Carm Catania and Police Chief Wayne Baumgart. Fire Chief Anthony Hutton arrived later in the meeting.

## MINUTES OF THE APRIL 2, 2012 COUNCIL MEETING:

Mr. Webbe moved to waive the reading of the Minutes, with the second by Mr. Kirek. The motion of Council passed by unanimous vote. Mr. Webbe moved to adopt the Minutes, with the second by Mr. Kirek. ROLL CALL: MOTION CARRIED 5/0/1 (VOTING YEA: SKRBIS, WEBBE, CATANIA, KIREK AND POWELL. VOTING NAY: NONE. ABSTAINING: UMHOLTZ).

#### **DEPARTMENT REPORTS:**

Police Chief Wayne Baumgart did not present a formal report and no questions were asked of him.

<u>Service Administrator Carm Catania</u> advised that the brush collection is ongoing, noting that Ward 3 is being done this week, and Ward 4 will begin next week. Mr. Catania stated that work on the sidewalk should begin again in the next couple weeks. He advised that the asphalt plant opened today, so patching will begin in the next couple weeks, once the brush collection is complete.

Councilman Skrbis stated that he received a call from a resident regarding a septic odor on Billings Road near the intersection of Wilbert Drive. Mr. Catania stated that he will look into it.

<u>City Engineer Philip Kiefer</u> did not present a formal report. Responding to Councilman Powell, Mr. Kiefer advised that the ditching problem on Graylock Drive is in Willoughby Hills. Mr. Catania stated that he will contact Willoughby Hills to see if they can help with this issue. Councilman Powell requested the Mayor's involvement in working with Willoughby Hills, noting that the water flows from Kirtland into Willoughby Hills.

Finance Director Keith Martinet did not present a formal report and no questions were asked of him.

**<u>Law Director Daniel Richards</u>** gave no formal report and no questions were asked of him.

Mayor Tyler reminded Council members that the Ohio Ethics Commission financial disclosure statements are due today.

Read by title only. Noting that the legislation should receive three readings, Finance Director Martinet advised that this pertains to the OPWC notes that are paid twice each year. Responding to Councilman Powell, Mr. Martinet advised that the City has paid back approximately 25 percent; he noted that it is principal only, with no interest. The legislation was placed on First Reading.

Noting that Fire Chief Hutton is now present, Mayor Tyler stated that Chief Hutton was indisposed earlier this evening. The Mayor noted that there was a brush fire in Parkman, and while units from the Kirtland Fire Department were assisting with the call, Chief Hutton was needed for a rescue call in Kirtland. Chief Hutton advised that the brush fire truck was in Parkman, noting that three members of the Kirtland Fire Department are still on the scene.
