KIRTLAND CITY COUNCIL MINUTES

April 1, 2013

The meeting of Kirtland City Council was called to order at 7:06 p.m. by Council President R. Robert Umholtz. Mr. Webbe led the prayer which followed the Pledge of Allegiance. <u>Police Chief Wayne Baumgart</u> advised that the formal report will be distributed next week.

<u>Service Administrator Carm Catania</u> did not present a formal report. Referring to property on the southwest corner at the Route 6 and Route 306 intersection, Councilman Schulz stated that there is still debris on the property following the removal of the structure. Mr. Catania stated that he will follow-up on this matter.

Councilman Webbe commented on the helpfulness of Service Department employee Justin Gollin during the Easter egg hunt at the Community Center this past weekend, noting that Justin's work was "over and above" what he needed to do. Mr. Webbe requested that Service Administrator Catania relay Council's appreciation to Justin for all of his work.

Mr. Catania advised Council that, weather permitting, the contractor will re-stripe the intersection at Lakeland Community College next week.

<u>City Engineer Philip Kiefer</u> did not present a formal report. Councilman Webbe inquired if the work at the bottom of the hill is on schedule. Mr. Kiefer advised that a submittal will soon be made to the EPA.

Finance Director Keith Martinet gave no formal report and no questions were asked of him.
