KIRTLAND CITY COUNCIL MINUTES

December 16, 2013

The meeting of Kirtland City Council was called to order at 7:07 p.m. by Council President R. Robert Umholtz. Mr. Schulz led the prayer which followed the Pledge of Allegiance. The members of Council present were: William Catania, Douglas Davidson, David Kirek, Timothy Powell, Matthew Schulz, Robert Skrbis and R. Robert Umholtz.

Administrative personnel present were: Mayor Mark A. Tyler, Law Director Daniel Richards, Finance Director Keith Martinet, City Engineer Philip Kiefer, Fire Chief Anthony Hutton and Police Chief Wayne Baumgart.

MINUTES OF THE DECEMBER 2, 2013 COUNCIL MEETING:

Mr. Kirek moved to waive the reading of the minutes, with the second by Mr. Catania. The motion of Council passed by unanimous vote. Mr. Kirek moved to adopt the Minutes, with the second by Mr. Catania. ROLL CALL: MOTION CARRIED 7/0 (VOTING YEA: CATANIA, DAVIDSON, KIREK, POWELL, SCHULZ, SKRBIS AND UMHOLTZ. VOTING NAY: NONE).

DEPARTMENT REPORTS:

Fire Chief Anthony Hutton did not present a formal report and no questions were asked of him.

<u>Police Chief Wayne Baumgart</u> requested that Sgt. Ronald Andolsek come forward, noting that he is being promoted to the Executive Officer position according to Contract (Lieutenant) and will be sworn-in at tonight's meeting. Chief Baumgart spoke highly of Sgt. Andolsek, noting that he was responsible for the convictions in the Lundgren case and many other cases over the years. Mayor Tyler administered the oath, and Lieutenant Andolsek received the applause and congratulations from all those present.

City Engineer Philip Kiefer advised that his monthly report for November has been distributed.

<u>Finance Director Keith Martinet</u> advised that he has prepared the November financial statements, noting that they will be posted and distributed this week. With regard to the budget, Mr. Martinet stated that he and the Mayor met with all of the Department Heads and that the budget will be presented early next year.

Mr. Martinet noted that the amended appropriation is on tonight's agenda. Mr. Martinet advised that he distributed a memo regarding the changes, noting that additional funding was received and disbursed for several capital projects; he stated that there were no changes to the General Fund or any of the Operating Funds.

Law Director Daniel Richards did not present a formal report and no questions were asked of him.

Finance Director Martinet advised that every attempt to collect these charges has been taken, noting that statements have been sent throughout the year and a final statement was sent by certified mail to the property owners advising of the action the City would take if the charges were not paid. Mr. Martinet advised that this legislation needs to be adopted tonight so it can be certified to the County Auditor to place these charges on next year's tax duplicate. Responding to an inquiry from Councilman Davidson, Mr. Martinet stated that these charges are at least three months delinquent. Councilman Powell suggested that if there is a topic that any Council members would like to discuss, they should advise the Clerk so it can be placed on the agenda.
